_____If the special event is for a period of seven days or more and planned for more than 50,000 attendees, the temporary signs may be displayed thirty (30) days before the commencement of the event and shall be removed within seven days after the event.

DO NOT PLACE SIGNS IN THE RIGHTS-OF-WAY

REQUIREMENTS PER SIGN CODE

You must meet the following requirements:

1. **Signs are prohibited within rights-of-way.**
2. Signs are prohibited on telephone or electric poles.
3. Signs are prohibited on trees.
4. Signs can be placed on PRIVATE property only with the permission of the property owner, and must be placed five feet (5') inside the property line on the private property.
5. Sign size is based on the zoning of the property where the sign is being placed. Please contact the Zoning Department at (904) 278-4705 with the legal description of the property in order to determine the zoning of the property and what size sign may be posted.
6. When a Temporary Special Event Sign Permit Application is completed, please return to the Code Enforcement Division, at P. O. Box 1366, 2497 SR 16 West, Green Cove Springs, FL 32043 or fax to 278-3631 Attention: Cheryl Miller. A decision will be rendered within ten (10) days after an application is submitted.]
