

RESOLUTION #2016/2017-74

WHEREAS, the tentative budget for fiscal year 2017-2018 was approved by the Board of County Commissioners of Clay County FL on September 12, 2017, and

WHEREAS, the County Budget Officer has made revisions to the estimated revenues for the fiscal year 2017-2018, and


