

RESOLUTION # 11/12-104

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF CLAY COUNTY, FLORIDA, ADOPTING THE FINAL LEVY OF AD VALOREM TAXES FOR CLAY COUNTY (INCLUDING SPECIAL TAXING DISTRICTS AND DEPENDENT TAXING DISTRICTS IN CLAY COUNTY) FOR FISCAL YEAR 2012-2013; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Clay County, Florida, on September 11, 2012, adopted Fiscal Year 2012-2013 Tentative Millage rates following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the Board of County Commissioners of Clay County, Florida, advertised pursuant to Sections 129.03(b) and 200.065, Florida Statutes, its Summary of Statement Notice in the *Clay Today* on September 20, 2012; and

WHEREAS, the Board of County Commissioners of Clay County, Florida, held a final public hearing on September 25, 2012, at 5:05 p.m., as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation has been certified by the County Property Appraiser to the Board of County Commissioners as \$7,903,951,877.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Clay County, Florida, that:

The Fiscal Year 2012-2013 proposed aggregate millage rate is 7.5909 which is less than the current year aggregate rolled-back rate of 7.8632 by 3.46%.


The proposed operating millage rates are broken down as follows:

<i>General Fund (EMS)</i>	<i>1.2000 mills</i>
<i>General Fund (Other County Services)</i>	<i>.3684 mills</i>
<i>Fine & Forfeiture Fund (Law Enforcement)</i>	<i>3.4043 mills</i>
<i>Unincorporated Services MSTU Fund</i>	<i>0.1875 mills</i>
<i>Law Enforcement MSTU-4 Fund</i>	<i>2.1860 mills</i>
<i>Fire Control MSTU-8 Fund</i>	<i>0.5048 mills</i>
<i>Lake Asbury MSBD</i>	<i>0.0000 mills</i>


